In addi	tion to the "General Conditions of Probation," you will also be required to:
1.	Report to the DWI "Sobriety" Drug Court Coordinator in person twice (2) weekly on Monday's and Wednesday's or as required by the DWI "Sobriety" Drug Court Coordinator.
2.	Attend one (1) scheduled weekly Individual Counseling Session, at a.m. / p.m.
3.	Attend one (1) MRT session weekly every Monday at 4:00 / p.m., and complete Steps 7– 10 of MRT sessions before advancement to Phase 4.
4.	Submit to random urinalysis, mouth swabs and/or breathalyzer content (BAC) tests of no less than three (3) times per week through out the program or as required by the DWI "Sobriety" Drug Court Coordinator or Treatment Provider. (Which shall be negative).
5.	Appear before DWI "Sobriety" Drug Court Judge, (1) once every week on Thursday's at 4:00 p.m., or as required by the Judge.
6.	Attend at least three (3) weekly 12 Step Meetings AA/NA meetings and provide written verification as required by the DWI "Sobriety" Drug Court Coordinator (if participant refuses based on religious beliefs, an alternative may be accepted based on Team's approval)
7.	Maintain a minimum of (15) hours per week of employment or enrolled in a full-time educational plan or (15) hours of community service per week (exceptions may be considered, reviewed and approved by the Sobriety Drug Court Team).
8.	Any other treatment requirements recommended by the treatment team and approved by the Sobriety Drug Court Team.
9.	Continue to contact sponsor and meet sponsor for one hour at least once per week and provide written verification as directed by the DWI "Sobriety" Drug Court Coordinator, if required.
10.	Take medication if ordered and prescribed.
11.	Participants must complete a relapse prevention plan that has been approved by the Sobriety Drug Court Team prior to entering Phase IV.
12.	Participants will graduate to Phase IV of the program once they have completed eight (8) successful weeks in Phase III. The Sobriety Drug Court Team will be involved and must agree to the advancement of each participant in each weekly phase.
13.	The Sobriety Drug Court Team will review participant's activities each week. Both the treatment specialist and the Sobriety Drug Court Coordinator will make recommendations for movement to the next phase. The Sobriety Drug Court team will make the final determination for forward movement to the next Phase.
14.	Other:

Total number of weeks required to complete Phase III: 8 Weeks

I understand and agree to abide by all the conditions of the Phase III Contract. Any violation of these conditions, including any positive drug tests; may result in possible incarceration, no advancement to the next program week, being returned to Phase II, or expulsion from the program.
